

### **Maternity Related Living Expenses:**

Florida adoption law allows for the payment of reasonable living expenses related to the pregnancy and that may include housing, transportation, medical, clothing, child care, utilities and cell phone costs. There are limits and some restrictions but if the cost is necessary and reasonable, Florida law allows the payment.

### **Family Section**

We will help you make all the critical decisions about who you select to adopt your child:

- You tell us who are looking for: age, race, marital status, number of children, religion, employment, education, location, and family structure, and we will find you that family.
- We then present to you the families that are interested in adopting with you and you select them from their applications.

### INTERVENTIONS AND THE DEPARTMENT OF FAMILY AND CHILDREN

Many people don't know that if the State has opened a dependency case against a parent regarding your children you do have options:

- a) if it doesn't look like you are going to be able to complete the case plan,
- b) the State has indicated they are going to seek to terminate parental rights, or
- c) the facts of the case are pretty clear that they are going to terminate parental rights,

you can always elect to start the Intervention process with us. This is where we would help you locate a family that wants to adopt your child or children and we help them intervene into the DCF case and allow for a private adoption. It is always best to do this early in the dependency case so the children have as little disruption as possible.
